Expression of Interest – Rare Spares Rockynats Car Festival Charity and Fundraising Recipient

There is an opportunity available within Rare Spares Rockynats 2022 for charitable organisations or community groups to become involved and undertake a specific activity or fundraising opportunity through the 2022 event.

Eligibility

Section A – Eligibility Requirements

- The application deadline is **Monday 31 January 2022.**
- Only complete applications will be eligible for consideration.
- Only registered, incorporated, not-for-profit organisations are eligible.
- Organisations must service the people of Rockhampton and the immediate surrounds.
- Organisations must be able to supply 10-20 volunteers across the three event days in roles which will benefit the event (this does not include donation collection roles)
- The fundraising opportunity for the selected charity must be used for a specific activity or purchase, which must be detailed in this application.

Section B – Ineligibility Criteria

Fundraising opportunities will <u>not</u> be considered for the following:

- Profit ventures and organisations;
- Short term/pilot projects;
- Organisations with political affiliations.

Section C – Opportunities and Partnership with Selected Charities and Community Groups

It is the intent of Rare Spares Rockynats to develop a positive and enthusiastic partnership with a charity and community groups selected to receive funds from the Rare Spares Rockynats Event. Recipient charities are required to make commitments to participate in the following:

Section D – Right of Recourse

Section E – Purpose of Funds

Funds received must be used in support of the project/s described on the application. Any desired changes to the allocation of funds will require pre-approval.

Section F – Follow up Requirements

The selected charity will be required to acknowledge support from Rare Spares Rockynats for a minimum of one calendar year after receipt of Rockynats fundraising (one calendar year being from the date the funds are actually received – this may vary from year to year).

The selected charity will be required to submit an evaluation report within three months of receiving the donation detailing the use of Rare Spares Rockynats funds. Failure to comply with the reporting requirements may result in the charity being ineligible for future Rare Spares Rockynats and event fundraising opportunities.
